Admission Requirements

- Applicants must meet **all** of the following criteria:
 - Hold a Diploma or Degree from a CCE-accredited chiropractic institution (DC)
 - Maintain current professional license in good standing with your licensing body
 - Hold a Certificate in Animal Chiropractic from an AVCA-approved program (minimum of 210 hours)
 - Have completed a minimum 200-hour acupuncture program (in accordance with WHO guidelines), accredited by one of the following:
 - The Council on Chiropractic Education
 - An accredited Canadian or American college/university
 - An accredited school of acupuncture
 - Confirm understanding of the applicable CCO Standards of Practice:
 - **S-001:** Scope of Practice
 - **S-009:** Chiropractic Care of Animals
 - **S-017:** Acupuncture
(or relevant provincial equivalents)
 - Carry professional liability insurance that includes coverage for acupuncture

Application Submission Requirements:

- Provide proof of current chiropractic licensure in good standing
- Provide proof of completion of an AVCA-approved Animal Chiropractic program
- Provide proof of completion of an accredited acupuncture program
- Submit fee payment before the virtual component of the program begins (May 23, 2024).
